Press F2 or Del or touch top left of the screen while [Panasonic] boot screen is displayed.  
Select [Load Default Values] and set [UEFI boot] to "Enabled".  
Select [Save Values and Reboot].

When a mouse pointer is moved unintentionally, please set a registry key to Windows PE boot image(wim) in the following steps:

1. Mount the boot image by using DISM on Windows PE(not a full Windows)
2. Load the registry hive file(<path\_to\_mount\_directory>%windows%system32%config%system) , and add the following registry key  
("Temp" is a temporary key)  
[HKEY\_LOCAL\_MACHINE\Temp\ControlSet001\Enum\ACPI\PNP0501\%a%Device Parameters]  
SkipEnumerations=dword:ffffffe
3. Unload the registry hive file and unmount the boot image
4. Import the boot image to SCCM/MDT
